Navratri (Annual Dance festival), Diwali (Hindu New Year), Seniors' Trips (Turkish Cruise), BBQ Sports day, Missing persons Charity Dinner and Dance. We hosted a follow "Hot Topic" convention for networking and mentoring. This year our events resulted in a surplus.
