1. Welcome to All
2. Minutes for the AGM held in Sep 2021 – These were approved as accurate by two attendees who were present at that meeting. (Rohitbhai Moti Chovisi, Rajeshbhai Toli)
3. Overview of year 2021 & Presentation of Accounts for 2021
  - a. Shaylesbhai gave a brief summary of the 2021 accounts (including the single face to face event held that year and the monies raised for the Covid appeal) and no questions were asked by the attendees present.
  - b. Unanimously Approved (led by Sheilaben, chikhli Dungar and Hitesh Dayalji Samthan): the accounts for the year ended 31st Dec 2021, which were summarised in the newsletter (issued in Q2 2022) giving notice of the AGM.
